<u>Lelm Estates – Norman Lelm</u>: Motion by Jack Kopp, second by Manley Olson to accept the Lelm Estates Preliminary Plat with no issues at this time as forwarded by the Sunrise Township Planning Commission. Motion carried.

<u>Jerrold Carlson – Sketch Plat (143 acres being platted into 5 lots):</u> Motion by Shane Stepp, second by Manley Olson to accept preliminary sketch plat with the following recommendations:

- 1. Town Board would agree with a County variance of Block 2, Lots 1 and 2 to have 298 feet (north / south dimension) on back leaving a 66 foot corridor on the north side of Lot 1 Block 2 for future development; and,
- 2. 33 foot street reservation easement on the east side of Block 1 Lot 1. Motion carried

<u>Joywood 2nd Addition Preliminary Plat – Joe Carchedi</u>: Motion by Jack Kopp, second by Shane Stepp to accept the Preliminary Plat of three (3) lots with the following conditions:

- 1. Joywood will go to North Boundary Line, and existing temporary hammer-head to be moved to north property line.
- 2. Joywood north from turnaround to north boundary to be black topped, and
- 3. Out lot needs to be dissolved and road needs to be dedicated to the Township Motion carried.

<u>Hidden Haven North – Warren White</u>: On Recommendation of Warren White; motion by Jack Kopp, second by Gerald Bjork with to accept the recommendation of Warren White to reduce the escrow to \$15,000 (reduction of \$17,000.00). Motion carried.

- Annual review
