**Approve Agenda** Motion by Eric Leivian, second by Joel Peterson to accept the July 2015 agenda. Motion carried.

**Meeting Minutes** Motion by Joel Peterson, second by Eric Leivian approve the June 2015 minutes. Motion Carried.

**Clerk Update:** Clerk Kowalke read Chisago County Historical Society thank you letter.

**Don Aherns – Driveway Culvert:** Mr. Aherns property is in Sunrise Township, but the culvert is in his driveway. Sunrise has no liability with this culvert.

**Sunrise Cemetery:** Anita Deming, Board Member, was present to talk with the Sunrise Town Board about the condition of the Sunrise Cemetery. Jed Wilcox said that he is having a hard time keeping companies wanting to mow because it is labor intensive. Ms. Deming thanked the Board for the donation. Place on Annual Meeting agenda. Sunrise Cemetery Board is asking Sunrise Town Board to help obtain a contract to keep the Sunrise Cemetery maintained.

**Chisago County Road Agreement:** Sunrise Township did not have a choice to have roads reallocated to Sunrise from Chisago County. Agreement was signed.

**Retro-Reflectivity:** Motion by Eric Leivian, second by Joel Peterson to accept the Retro-Reflectivity Policy. Motion carried.

**Homeland Security – Disaster Grant (Joel Peterson):** Joel Peterson is finishing up paperwork with Homeland.

**Insurance:** Motion by Eric Leivian, second by Gerald Bjork to Increase deductible from \$250 to \$1,000 for a savings of \$307.00 per year. Town board would like to lower the value of old town hall to \$75,000.00. Motion carried.

**Building Quotes:** Lynn Wolleat obtained 2 building prices for a 40 x 40 building, 16 ft walls, 14 ft. slider and service door (these were not quotes). Sunrise Town Board will take these prices under advisement.
