### **Snowplowing**

Excerpt taken from 160.2715 RIGHT-OF-WAY USE; MISDEMEANORS.

(a) Except for the actions of the road authorities, their agents, employees, contractors, and utilities in carrying out their duties imposed by law or contract, and except as herein provided, it shall be unlawful to:

(1) Obstruct any highway or deposit snow or ice thereon;

Any violation of this section is a misdemeanor and will be enforced.

It is illegal to push snow across the road.

### **Swing Type Mailbox Support Required**

Any mailbox placed within a Sunrise Township right-of-way must have a swinging-arm mailbox support of the type approved by the Minnesota Department of Transportation, which will not protrude into the traveled surface of the right-of-way and will comply with all U.S. Postal Service mailbox regulations. These are available for purchase from the Township. Sunrise Township is not responsible for replacing or repair to any non-conforming mailboxes.

### **Emergency Blue Signs:**

Sunrise Township entered into a grant agreement with the State of Minnesota on January 1, 2017 through June 30, 2018 to have emergency blue signs placed. Any new builds after June 30, 2018 will be charged \$125.00 for emergency blue signs and installation. Replacement signs will also be \$125.00
