**RE: Adoption of Chisago County Ordinances
as Governing Authority**

Board Member Joel Peterson offered the following resolution and moved its adoption with a second by Gerald Bjork:

**SUNRISE RESOLUTION NO 090618-1
ADOPTING CHISAGO COUNTY ZONING ORDINANCE;
CHISAGO COUNTY SUBDIVISION ORDINANCE; CHISAGO COUNTY SEWAGE AND WASTEWATER
TREATMENT ORDINANCE; AND CHISAGO COUNTY SHORELAND MANAGEMENT ORDINANCE**

WHEREAS, In Accordance with Minnesota Statutes 462.358, subd. 1a a municipality may by resolution extend the application of its subdivision regulation to unincorporated territory located within two (2) miles of its limits in any direction, but not in a town which has adopted subdivision regulations; provided that where two or more noncontiguous municipalities have boundaries less than four miles apart, each is authorized to control the subdivision of land equal distance from its boundaries within this area; and

WHEREAS, In Accordance with Minnesota Statutes 462.357, subd. 1, ... Any city may thereafter enforce such regulation in the area to the same extent as if such property were situated within its corporate limits, *until the county or town board adopts a comprehensive zoning regulation which includes the area; and*

WHEREAS, Sunrise Township held a Public Hearing on Thursday, May 21, 2009 at 6:30 p.m. to propose to the citizens of Sunrise Township the Adoption of the Chisago County Zoning Ordinances, Subdivision Ordinance, Sewage and Wastewater Treatment Ordinance, and Shoreland Management Ordinance.

WHEREAS, It is be in the best interest of Sunrise Township to adopt the above mentioned ordinances to protect itself from annexation.

NOW, THEREFORE, BUT IT RESOLVED, Sunrise Township hereby adopts the following Chisago County Ordinances:

- **ADOPTING CHISAGO COUNTY ZONING ORDINANCE (08-3)**
- **CHISAGO COUNTY SUBDIVISION ORDINANCE (99-2)**
- **CHISAGO COUNTY SEWAGE AND WASTEWATER TREATMENT ORDINANCE (98-1)**
- **CHISAGO COUNTY SHORELAND MANAGEMENT ORDINANCE**
